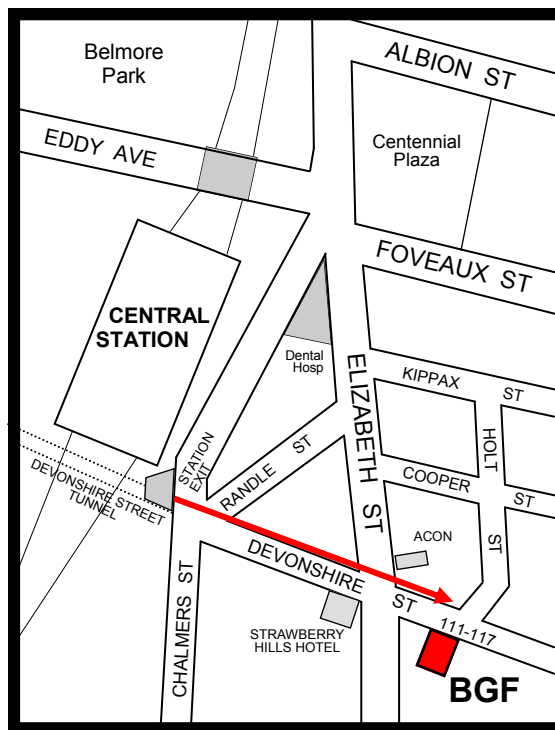
How to get there?

offers an alternative to public housing and the private rental market. Tenants and properties are managed by non-government, not-for-profit Community Housing Providers (CHPs) who provide rental housing at discount to market rent for people on low to moderate incomes including those who require support to secure and maintain appropriate housing. CHPs manage social, affordable and supported housing.

The Inner Sydney Tenants Advice and Advocacy Service ...

provides free tenancy advice, assistance and advocacy.^ They have extensive experience in assisting people living with HIV to resolve housing concerns. Similar services operate throughout New South Wales including generalist services and specialist services for Aboriginal tenants, older tenants and residential park tenants.
